SUPPORT THE ANJANETTE YOUNG ORDINANCE

Stop Home Raids that Traumatize and Harm Chicago's Black and Brown Children and Families Chicago Police Department's Revised Search Warrant Policy Allows Raids to Continue.

Across Chicago's Black and Brown communities, police invade homes often based on faulty search warrants. Police break down doors, point guns at children, and traumatize people—often targeting the wrong people.

The brutalizing raid on Anjanette Young is just one example. Chicago police broke down her door without giving her a chance to respond. She was handcuffed and naked in front of police with guns drawn while they wrongfully raided her home.

The Anjanette Young Ordinance, 02021-764, was developed with input from Ms. Young and communities most impacted to help end to these violent home raids, including raids on the wrong home.

On March 3, 2021, the CPD posted draft changes to its search warrant execution policy for public comment. Of more than 788 comments, 82% said the policy did NOT do enough to curb wrong raids. 56% of the comments called for passage of the Ordinance.

On May 14, 2021, CPD issued a revised Search Warrant Policy (Special Order S04-19), which still fails to end wrong raids.
