DECLARATION OF PATRICIA DAVIS

- 1. My name is Patricia Davis. I make this Declaration based on personal knowledge.
- I am presently employed by The Harris Corporation ("Harris"). My job title currently
 is Return Manufacturer Authorization Representative. I have held this position since
 August 1, 2012.
- 3. My job responsibilities include overall oversight of Harris's contract with the Chicago Police Department ("CPD") with respect to any returns, upgrades and/or maintenance of the system commonly known as a "Stingray."
- 4. In this capacity, my principal contact with CPD during the relevant time was Sgt. Jack Costa.
- The Stingray system requires regular upgrades and maintenance to ensure continuing functionality.
- I have reviewed Harris records kept in the ordinary course of business pertaining to that system, including records documenting shipping and receipt of system components for repair, maintenance and/or upgrade.

- 7. On or about December 22, 2014, Harris received major essential components of CPD's system which required upgrade and which CPD had shipped via Federal Express.
- On or about April 7, 2015, Harris returned the essential components of CPD's system to CPD, again by Federal Express.
- 9. While Harris was in possession of the components of the CPD system which had been shipped to it in December 2014, and at least until those components had been returned to CPD on or about April 7, 2015, CPD would not have been able to deploy or utilize that CPD system.
