Katherine and I want children in the future and we intend in the future to seek to become licensed foster parents in Illinois and in having a state ward placed in our home for foster care and possibly adoption. We are interested in fostering special needs children and children of color. We further have an interest in being available as foster parents to all of the children in the DCFS system and not being denied the ability to foster some children on the basis of their sexual orientation, especially since it may be in a particular child's best interest to be placed with us considering the unique needs of the child and the skills and qualities that we can offer.

Katherine and I have friends and family members who were fostered and adopted and have seen the good it can do in the lives of the foster children and the families who make their homes available to them. We are not interested in having biological children and would prefer to expand our family through other means, including through the foster care system.
